M. C. Office for Greenville County in Plat Book F, at pages 131 and 132, and having, in the aggregate, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the south side of Oregon Street at the joint corner of Lots Nos. 4 and 5, of Block B, which point is 240 feet east of the southeast corner of the intersection of Oregon Street and Mitchell Street, and running thence along the joint line of said lots, S. 26-30 E. 165 feet to an iron pin, joint rear corner of said lots; thence N. 63-35 E. 62 feet to an iron pin, which point is two feet east of the rear corner of Lots Nos. 5 and 6; thence on a new line across Lot No. 6 parallel with the line of Lot No. 5 and being two feet distance therefrom, N. 26-30 W. 165 feet to an iron pin on the south side of Oregon Street, said pin being two feet east of the corner of Lot No. 5; thence along the south side of Oregon Street, S. 63-35 W. 62 feet to the beginning corner, and being a portion of the property conveyed to me by Merle D. Miller by deed dated April 25, 1946, and recorded in the R. M. C. Office for Greenville County in Deeds Vol. 290, page 282."
