"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, known and designated as a part of the subdivision known as Hunters Acres. A plat for which was made by W. J. Riddle in May 1952 and is recorded in the R. M. C. Office for Greenville County in Deed Book BB, page 41. This lot, more fully described as Number 78, is located on the South side of Benson Street beginning at an iron pin located on the South Side of Benson Street 520 feet West of the intersection of Benson and Maple Street Extension. Lot Number 78 is 80 feet wide facing Benson Street on the North, bordering Lots No. 79, 80, and 81, 342' 9", on the West by branch, 87' 5" and on the South by lot No. 77, 299' 6" East.
