MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

VILLE, in the full and just sum of Ten Thousand, Eight Hundred and No/100 - - - - - -(\$ 10.800.00) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

"BEGINNING at an iron pin on Meridian Avenue and being joint front corner of Lots 124 and 123; and running along joint side line of Lots 124 and 123, N. 71-06 W. 191.1 feet to the center of a five foot strip in the rear reserved for utilities; thence along said five foot strip, S. 2-00 W. 135 feet to a point and being joint rear corner of Lots 124 and 125; thence along joint side line of Lots 124 and 125, S. 81-44 E. 183.6 feet to an iron pin on Meridian Avenue; thence along Meridian Avenue, N. 2-16 E. 100 feet to the point of beginning; being the same conveyed to me as Truman Edwin Watson by Elise Coster Prince, et al. by deed dated April 9, 1955 and recorded in the R.
