All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina on Haynswroth Road, near the City of Greenville, S. C., being known and designated as lot Nos. 1, 2, and 3 of the property of H. L. Baumgardner and L. T. Jones, being a portion of Haynsworth Heights and having, according to a plat made by W. J. Riddle, Surveyor, February 1949 and recorded in Plat Book"V" at page 65, the following metes and bounds:
