and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon,
situate, lying and being near the City of Greenville, in the County of Greenville,
State of South Carolina, being known and designated as Lot No. 47 on Plat of Augusta
Acres, which plat is recorded in the R.M.C. Office for Greenville County, South
Carolina, in Plat Book "S", page 201; said lot having a frontage of 100 feet on the
Southerly side of Meadors Avenue, a depth of 200 feet on the West, a depth of 200
