Eunice A. Baswell, her heirs and assigns forever:

All that certain piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, lying and being on North Haven Drive, and being known and designated as Lot #43 of Buncombe Park, as shown on plat recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "M", Page 12 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of North Haven Drive, joint front corner of Lots 42 and 43, and running thence N. 3-20 W. 173 feet to an iron pin, joint rear corner of Lots 42 and 43; thence N. 88-00 E. 60 feet to an iron pin, joint rear corner of Lots 43 and 44; thence S. 3-20 E. 173 feet to an iron pin on the Northern side of North Haven Drive, joint front corner of Lots 43 and 44; thence along North Haven Drive, S. 88-00 W. 60 feet to the beginning corner.
