all that tract or lot of land in Township, Greenville County, State of South Carolina.

ALL that certain piece, parcel or lot of land on the east side of S. C. Highway No. 291 near the City of Greenville, County of Greenville, State of South Carolina being known and designated as Lot No. 11 according to plat of property of J. H. Sitton, et al dated January 11, 1956 by Piedmont Engineering Service and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern edge of the right of way of Highway No. 291, said pin being 675 feet south of the southeastern intersection of Edwards Road and Highway No. 291 and running thence S. 88-20 E. 194.75 feet to an iron pin on a 30 foot service alley; thence with said alley S. 0-43 W. 218.7 feet to an iron pin; thence S. 83-53 W. 196.3 feet to an iron pin on the eastern right of way of Highway No. 291; thence with the eastern edge of the right of way N. 0-30 W. 150 feet to a point; thence continuing with said right of way N. 0-38 E. 95 feet to an iron pin, point of beginning.
