WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Three Thousand and No/100- - - -**

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot # 14, Block D, of Riverside, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book K at Page 281, and according to said plat, having the following metes and bounds, to-wit:

"BEGINNING at a point on the North side of Palmetto Avenue, joint front corner of lots # 14 and 15, and running thence with Palmetto Avenue, N. 79-45 W. 50 feet; thence with line of lot # 13, N. 10-15 E. 125 feet to an alley; thence with said Alley, S. 79-45 E. 50 feet; thence S. 10-15 W. 125 feet to the point of beginning."
