**MORTGAGE**

WHEREAS: - - - - - HENRY FURMAN HUGHEY - - - - -

Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to  
- - - - - C. DOUGLAS WILSON & CO. - - - - -

a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of EIGHT THOUSAND FIVE HUNDRED & NO/100-- - - - Dollars (\$ 8,500.00 ), with interest from date at the rate of four and one-half per centum ( 4½ %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of - - - - - Forty-Seven & 25/100- - - - - Dollars (\$ 47.25 ), commencing on the first day of February, 1956, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January, 1981.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina;

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 24, North Acres, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "EE", pages 12-13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Neal Circle at the Northwest corner of a lot marked "Sold", and running thence N. 79-10 E. 100 feet to an iron pin; thence N. 10-50 W. 70 feet to an iron pin; thence S. 79-10 W. 100 feet to an iron pin on the Easterly side of Neal Circle; thence along the Easterly side of Neal Circle, S. 10-50 E. 70 feet to an iron pin, the point of beginning.

This mortgage is a substitute or supplemental mortgage given to secure the note of even date in lieu of the mortgage dated December 8, 1955, recorded in the R.M.C. Office for Greenville County in Mortgages Volume 662, page 31. The purpose of this mortgage is to correct the description of the security property to show the proper point of beginning and does not in any way alter any of the terms, conditions or agreements of the original instrument.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
