WHEREAS, the Mortgagor is well and truly indebted unto

C. Douglas Wilson & Co. , a corporation
organized and existing under the laws of South Carolina , hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of Eighty-seven Hundred -
Dollars (\$ 8700.00), with interest from date at the rate of four & one-half per centum
(4½ %) per annum until paid, said principal and interest being payable at the office of
C. Douglas Wilson & Co. in Greenville, S. C. ,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Forty-eight and thirty-seven one-hundredths Dollars (\$ 48.37),
commencing on the first day of July , 19 56, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of June , 19 81.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville ,
State of South Carolina:

All that lot of land in the city of Greenville, county of Greenville,
state of South Carolina, being known and designated as Lot No. 8, on
plat of Carver Court, recorded in plat book II page 107 of the R.M.C.
Office for Greenville County, S. C., and having according to a recent
survey made May 1956 by R. W. Dalton, the following metes and bounds,
courses and distances, to-wit:

Beginning at an iron pin on the northwest side of Elder Street, the
front joint corner of Lots Nos. 8 and 9; thence with the joint line of
said lots N. 43-13 W. 147.6 feet to an iron pin; thence S. 52-58 W.
53 feet to an iron pin corner of Lot No. 7; thence with the line of
said lot S. 37-02 E. 156 feet to an iron pin on the northwest side of
Elder Street; thence with the northwest side of said street N. 52-58 E.
33 feet to an iron pin; thence with the curve of said street, the
chord of which is N. 38-15 E. 37 feet to the beginning corner.
