MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Eight Thousand, Three Hundred and No/100 - - - - - - - - (\$ 8,300.00 ) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 26 on plat of Cedar Lane Gardens, dated August 27, 1955, recorded in the R. M. C. office for Greenville County in Plat Book GG, page 139, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at a point on the Southeast side of Jonquil Lane at the joint front corner of Lots 26 and 27, and running thence along the joint line of said lots, N. 53-00 E. 146.7 feet to a point in the rear line of Lot 21 (joint rear corner of Lots 26 and 27); thence along the joint rear line of Lot 26 and 21, S. 38-09 E. 75 feet to a point in the rear line of Lot 22 (joint rear corner of Lots 25 and 26); thence turning and running along the joint line of Lots 25 and 26, S. 53-18 W. 137.8 feet to a point on Jonquil Lane (joint front corner of last mentioned lots); thence along Jonquil Lane, N. 44-58 W. 75 feet to the point of beginning; being the same conveyed to me by Carl B. Holland by deed of even date herewith, not yet recorded."

The last payment on this mortgage, if not sooner paid, will become due and payable 20 years after date.
