All that piece, parcel or lot of land lying, being and situate about two miles northwest of the Town of Greer, on the north side of Endless Drive, in Chick Springs Township, County and State aforesaid, and being known and designated as Lot No. 5 of the W. Dennis Smith property as shown on plat prepared by H.S. Brockman, Registered Surveyor, dated Dec. 20, 1956, and having the following courses and distances, to-wit:
