NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of State of South Carolina:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot No. 59, Section 1, Oak-Crest recorded in Plat Book GG at Pages 130-131 in the R. M. C. Office for Greenville County and having according to a more recent survey by C. C. Jones dated April 5, 1957, to have the following metes and bounds, to-wit:

EEGINNING at an iron pin on the northern side of Lynhurst Drive at the joint front corner of Lots 58 and 59 and running thence with the line of Lot 58 N. 29-58 W. 150 feet to an iron pin; thence N. 60-02 E. 80 feet to an iron pin joint rear corner of Lots 59 and 60; thence with the line of Lot 60 S. 29-58 E. 150 feet to an iron pin on Lynhurst Drive; thence with said Lynhurst Drive S. 60-02 W. 80 feet to the beginning corner.
