with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid annually, and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The South Carolina National Bank and Julia Smythe Reeves as Executors of the Estate of T. B. Reeves, deceased

all that tract or lot of land in Gantt Township, Greenville County, State of South Carolina, with the buildings and improvements thereon, about 6 1/2 miles South of the City of Greenville, on the South side of East Gantt Street and being known as Lot No. 38, as shown on plat of property of Albert Q. Taylor, made by Dalton & Neves, May, 1946, and recorded in the Office of the R. M. C. for Greenville County in Plat Book P, page 49, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of East Gantt Street, which pin is 693 feet Southeast from the intersection of East Gantt Street and the Augusta Road, joint front corner of Lots 38 and 39, and running thence along the joint line of said lots, S. 40-15 W. 140.2 feet to a point, joint rear corner of Lots 38, 39, 36 and 35; thence along the joint rear lines of Lots 38 and 36, S. 53-42 E. 97.7 feet to a point, joint rear corner of Lots 38 and 37; thence along the joint line of said lots, N. 41-16 E. 133 feet to a point on the South side of East Gantt Street, joint front corner of Lots 37 and 38; thence along the South side of East Gantt Street N. 48-44 W. 100 feet to the point of beginning.
