"All this certain pieces parces or loss of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, on the northwestern corner of Paris Mountain Road and a proposed road being shown as Lots 9, 10 and 11 on plat No. 2 of the property of J. S. Fox made by Piedmont Engineering Service in May, 1953, and described as follows:
