NOW, KNOW ALL MEN, that first party, in consideration of the debt as evidenced by said note, and for better securing the payment thereof to second party, according to the terms of said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand paid by second party, receipt whereof is hereby acknowledged, has granted, bargained, sold and released, in fee simple, and by these presents does grant, bargain, sell and release, in fee simple, unto second party, its successors and assigns, the following described lands, including but not limited to, all trees, timber, shrubbery, fixtures and improvements now and hereafter thereon:

contained in the said note, evidencing a loan made by second party, will more fully appear by reference thereto.

All that piece, parcel and tract of land lying and being in Austin and Butler Townships, Greenville County, South Carolina, on the Greenville-Woodruff Highway and containing sixty and eight-tenths (60.8) acres, more or less, and consisting of the greater portions of tracts numbers 9 and 10 and all of tract number 11 as shown on plat of a subdivision of lands of J. M. Verdin as recorded in Plat Book L, page 61. Tract number 9 of the said lands was conveyed to W. H. Beattie Coker by J. M. Verdin by deed dated March 28, 1941, recorded in Deed Book 231, page 117. Tracts numbers 10 and 11 were conveyed to him by J. P. Verdin and D. B. Verdin and to the said J. P. Verdin and D. B. Verdin by L. S. Verdin by deed dated November 13, 1942, recorded in Deed Book 249, page 315. The three mentioned tracts of land adjoin each other and contain in the aggregate sixty-six and one-tenth (66.1) acres, and are fully set forth and described by courses and distances and metes and bounds on the plat recorded in Plat Book L, page 61. Described as a whole the said tract of land is bounded by lands now or formerly of H. Hobby, McCall and Tom Andy on the north; by the C. L. Sloan estate on the east, the Woodruff-Greenville Road on the south, with L. J. Vaughn and Mrs. J. P. Verdin lying across the road and J. P. Verdin on the west.

EXCEPTED from the aforementioned boundary however is a parcel of land cut off and conveyed away by W. H. Beattie Coker from the northwestern corner of the parcel and consisting of portions of tracts numbers 9 and 10 and containing five and threetenths (5.3) acres which said parcel was conveyed by the said W. H. Beattie Coker to A. J. McDonald by deed dated April 11, 1951, recorded in Deed Book 433, page 221 with that said parcel of land being fully described by courses and distances on a plat thereof made by J. Mac Richardson, Reg. Land Surveyor in April 1951 with that plat recorded in Plat Book 00, page 74, with reference being here made thereto for a more detailed description.
