To be computed and paid annually, as follows: \$1,000.00, plus
accrued interest to be paid January 25, 1959, the remaining \$1,000.00,
plus accrued interest to be paid on January 25, 1960. The mortgagor shall
have the privilege of anticipating any part of the principal or the
entire principal at any time without penalty,

with interest
from date at the rate of Six (6%) per centum per annum
until paid; interest to be computed and paid annually and if unpaid when due to
bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per

All that certain lot of land in Greenville County, located on
what is known as Base Hospital Road, or Old Rutherford Road, being
known and designated as Lot No. 22 of Mountain View Circle, according
to the subdivision and plat made by J. C. Hill, Surveyor, May 5, 1951,
as recorded in Plat Book W, at page 181, having according to said plat
the following metes and bounds, to-wit:

BEGINNING on the west side of Hospital Road, at the corner of
Lot No. 21, which is 100 feet North of the intersection of a street
with said Highway; thence with Lot No. 21, N. 81-35 W. 200 feet to the
joint rear corner of Lots Nos. 21 and 22; thence with the rear line of
