WHEREAS, the Mortgagor is well and truly indebted unto SOUTH CAROLINA NATIONAL BANK OF GREENVILLE, SOUTH CAROLINA, as trustee for Dorothy Grogan McBee under agreement dated June 7, 1948, as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Thousand and No/100 -

DOLLARS (\$2000.00 )

with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: PAYABLE: Three (3) years after date, with the privilege of

anticipating all or any part of the unpaid balance on any interest date with interest thereon from date at the rate of six (6%) per cent, per annum, to be computed and paid semiannually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the northern side of Augusta Road and being more fully described as follows:

BEGINNING at a point on the northern side of Augusta Road 185.3 feet northwest from Oregon Street and running thence N. 35-44 E. 216.2 feet to a stake; thence N. 41-28 W. 47 feet to a stake corner of property now or formerly owned by L. E. and Corrie Arnold; thence with the line of said property in a northwesterly direction 237½ feet, more or less, to a stake on the northeast side of Augusta Road; thence with the northeastern side of said road S. 55-56 E. 121 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by deed dated January 15, 1958, to be recorded herewith.
