in Greenville Township, on the Southern side of Walcot Street, formerly Poplar Street, near the City of Greenville, being shown as Lot No. 36 on Plat of property of B. M. McGee Trust Estate, made by W. J. Riddle in July 1942, recorded in Plat Book M, at page 51, and described as follows:
