"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Lockwood Avenue in the City of Greenville, being shown as Lot 86 on plat of property of H. C. Gibson, Elletson Acres, prepared by C. C. Jones dated Jamuary 29, 1958, recorded in Plat Book PP at page 63 and, according to said plat, being more particularly described as follows:

BEGINNING at an iron pin on the Northeast side of Lockwood Avenue at the front corner of Lot 85, running thence with the line of said lot, N. 56-06 E. 248.1 feet to an iron pin in the line of property now or formerly of the Vaughan Estate; thence with the line of said property N. 29-15 W. 80 feet to an iron pin; thence S. 60-28 W. 256.4 feet to an iron pin on the Northeastern sideof Lockwood Avenue; thence with the curve of said Avenue, the chord of which is S. 27-54 East 48.4 feet to an iron pin; thence continuing with the Northeast side of said Avenue S. 42-02 E. 50.4 feet to the beginning corner.
