To All Whom These Presents May Concern: I, Lee Alferd Vaughn

SEND GREETING:

Whereas, I, the said Lee Alferd Vaughn

hereinafter called the mortgagor(s)

in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to W. W. Wilkins

hereinafter called the mortgagee(s), in the full and just sum of Six Thousand - - - DOLLARS (\$ 6,000.00 ), to be paid six months from date

, with interest thereon from date

at the rate of six (6%) percentum per annum, to be computed and paid

at maturity

until paid in full; all interest not paid when due to bear

interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor(s) promise to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I, the said mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee(s) according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said mortgagor(s), in hand well and truly paid by the said mortgagee(s) at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said W. W. Wilkins

All that lot of land in the City of Greenville, Greenville County, State of South Carolina, known and designated as Lot No. 1 on plat of Property of J. W. Cannon, Inc. recorded in the RMC Office for Greenville County in Plat Book PP page 111, and being a portion of Lot No. 16, Block B, on plat of Glenn Farms, recorded in Plat Book M, page 75 of the RMC Office for Greenville County, and having according to the first mentioned plat, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southern side of Glenn Road, the front western corner of Lot No. 15 on plat of Glenn Farms; thence with the line of said lot, S. 30-00 E. 200 feet to an iron pin; thence turning S. 85-47 W. 60 feet to an iron pin, corner of Lot No. 2 on Cannon plat; thence with line of said lot, N. 28-37 W. 169 feet to the southern side of Glenn Road; thence with the southern side of Glenn Road, N. 54-24 E. 50.2 feet to the beginning corner.
