WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Town-, ship, located in the Pelham Mill Village, known and designated as Lot No. 109 on a plat of property of Pelham Mill Village, having the following courses and distances:

BEGINNING on an iron pin, corner of the C.B. Henson lot, and runs thence S. 79 W. 143 feet to an iron pin, corner with C.B. Henson and Gordon Satterfield; thence N. 16 W. 64 feet to an iron pin, corner with Gordon Satterfield and J.O. Duncan; thence N. 70 E. 164 feet to an iron pin on line of J.O.
