I, H. EDWIN MILLER of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

All that lot of land in the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 12 on plat of AUGUSTA HEIGHTS subdivision, recorded in Plat Book KK, page 88 of the R.M.C. Office for Greenville County, S. C., said lot having a frontage of 60 feet on the north side of Waverly Court, a parallel depth of 168.6 feet, and a rear width of 60 feet on the south side of Amherst Avenue.
