WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, containing 2 4/10 acres, more or less, and having the following metes and bounds as per survey of G. A. Ellis, Surveyor, May 3, 1947, to-wit:

BEGINNING at an iron pin on the Cleveland line Cole's corner; thence with Cleveland line S. 78 W. 400 feet to pin in big gully; thence N. 21 1/2 E. 350 feet to pin near big gully; thence N. about 70 E. 300 feet to pin at large boulder rock; thence S. 3 1/2 W. 350 feet to point of beginning.
