"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township near the town of Travelers Rest, being shown and designated as Lots 7 and 8 of Coleman Heights on plat by Terry T. Dill, May 24, 1956, recorded in Plat Book KK at page 29 and having the following metes and bounds:

BEGINNING at an iron pin on West side of West Drive, front corner of Lots 6 and 7; thence said lots S. 51-30 W. 279.2 feet to an iron pin in Thompson line; thence N. 50-30 W. 213.4 feet to an iron pin near corner 9A and 8; thence N. 51-30 E. 325 feet to West Drive; thence with said Drive, S. 38-30 E. 208.7 feet to the beginning.
