NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on the northwesterly side of Sevier Street, in the City of Greenville, being all of lot No. 1 as shown on the plat of the property of Willie H. Martin and C. B. Martin, recorded in the RMC Office for Greenville County, S. C. in Plat Book G, page 246, and an additional strip of land adjoining said Lot No. 1 on the northeasterly side, and having according to a plat made by Jones & Sutherland, dated November 4, 1958, entitled property of E. Floyd DuPree, the following metes and bounds, to-wit:

Jones and William Adrel Jones N 54-28 W 69.3 feet to an iron pin; thence S 33-27 W 102.2 feet to an iron pin, joint rear corner of Lots Nos. 1 and 2 as shown on the plat recorded in Plat Book G, page 246, above mentioned; thence along the joint line line of Lots 1 and 2 S 57-45 E 141.4 feet to an iron pin on the northwesterly side of Sevier Street; thence along the northwesterly side of Sevier Street N 32-40 E 92 feet to the point of beginning.
