"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Tp. on the eastern side of Keeler Bridge Road containing 16 acres, more or less, and according to survey made by W. A. Hester on July 26, 1944, is described as follows: BEGINNING at a point in the center of the bridge on the Keeler Bridge Road ad Armstrong Creek and running thence up and with said creek in an easterly direction 630 feet, more or less, to sycamore in the Armstrong Creek; thence continuing up and with the creek 13.24 chs. to a large rock; thence N. 24 E. 7.25 chs. to a WO tree; thence S. 34-30 E. 2 chs. to a stone; thence N. 20-30 E. 13 chs. to the mouth of branch; thence N. 28 E. 170 chs. to sycamore; thence S. 82-0 W. 3.87 chs. to a pine; thence S. 41 W. 4.05 chs. to poplar; thence S. 5-0 W. 4.10 chs. to iron pin at dam; thence S. 52-30 W. 1.60 chs. to a sweetgum; thence N. 89-0 W. 1.90 chs. to spanish oak; thence S. 72-0 W. 2.10 chs. to an iron pin; thence S. 78-0 W. 1.66 chs. to an iron pin; thence S. 29-0 W. 1.58 chs. to an iron pin; thence S. 35-0 E. 2.75 chs. to poplar; thence S. 27-0 E. 4.20 chs. to an iron pin at mill race; thence S. 6 E. 1.20 chs. to iron pin; thence due south 2.17 chs. to a pine; thence S. 18 W. 3.44 chs. to dogwood; thence S. 82 W. 900 chs. to center of Keeler Bridge Road; thence S. 31 E. 7.76 chs. to beginning.
