"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, about one mike southwest from Green, lying on the eastern side of a new road that leads by Matt's Fishing Lake, and having the following courses and distances, to-wit:

BEGINNING on a stake in the said road, joint corner of the John Oliver lot, and runs thence with the common line of the lot herein described and of the John Oliver lot, S. 40-13 E. 229.3 feet to a stake or iron pin on the I.M.
