in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The Citizens and Southern National Bank of South Carolina, its successors and assigns:

All that piece, parcel or lot of land, situate, lying and being on the Northerly side of the Jenkins Bridge Road, in the County of Greenville, State of South Carolina, being known and designated as the Property of W. David Ridgeway, Jr., as per plat thereof made by C. D. Riddle, Surveyor, December 3, 1952, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point near the center of the intersection of the Jenkins Bridge Road and a farm road, and running thence N. 32-37 W. 1247 feet to an iron pin on the Easterly side of the said farm road; thence N. 62-31 E. 457 feet to an iron pin; thence S. 22-00 E. 1088.5 feet to a point in the center of the Jenkins Bridge Road; thence through the center of the Jenkins Bridge Road S. 25-56 W. 132 feet to a point; thence continuing to the center of the Jenkins Bridge Road S. 32-29 W. 157 feet to the point of beginning, and containing 9.45 acres.

All that piece, parcel or tract of land in Fairview Township, Greenville County, and State of South Carolina and containing 38 and 78/100 (38.78) acres, more or less, and bounded as follows: On the North by lands of Mrs. Maggie Harrison and N. A. Henderson, on the East and South by lands of O. F. Henderson and Jenkins Bridge Road, on the West by land of Mrs. Maggie Harrison. It is the remainder of the 59-acre tract conveyed to J. P. Ashmore on December 10, 1932, by a deed recorded in Book 167, Page 96, Office RMC for Greenville County, and in which said J. L. Abernathy and Ida B. Abernathy were conveyed the other half interest by Ora Lee Ashmore on January 17, 1938, by deed recorded in Book 201, page 344.
