All that lot of land in the city of Greenville, county of Greenville, state of South Carolina, known and designated as Lot No. 7 on plat of Augusta Heights subdivision made by Dalton & Neves, April 1941 recorded in plat book K at page 88 of the RMC Office for Greenville County, S. C. said lot having a frontage of 66 feet on the southwest side of Tyler Street; a parallel depth of 190 feet and a rear width of 66 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
