WHEREAS, the Mortgagor is well and truly indebted unto **GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C.**, (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of  
Greer, Chick Springs Township, in a subdivision known as "Needmore"  
containing 15/100 of an acre, more or less, according to a plat thereof made by W.A. Christopher, Surveyor, and having the following courses and distances: BEGINNING at an iron pin in the center of Forest Street, and runs thence N. 72-20 W. 125 feet to an iron pin in an Avenue near a large oak 3m; thence N. 5 1/4 E. 56 feet to an iron pin; thence S. 72-20 E. 125 feet to an iron pin in the center of Forest Street; thence with said Street S. 5 1/4 W. 56 feet to the beginning, lying on the west side of Forest Street, being all of that lot described in deed recorded in Deed Book 230, at page 274, R.M.C. Office for Greenville County.

ALSO, all of that other parcel or lot of land adjoining the above lot, having the following courses and distances: BEGINNING at an iron pin in the center of Forest St., formerly Frohaw, St., and runs thence N. 72-20 W. 125 feet to iron pin; thence N. 5 1/4 E. 53 feet to iron pin; thence S. 75 1/4 E. 125 feet to iron pin in center of Forest St; thence with St., S. 5 1/4 W. 56 feet to beginning.
