To All Whom These Presents May Concern:

We, Bayliss Fursell Martin and Lanta Jean Martin SEND GREETING:

Whereas we, the said Bayliss Farrell Martin and Lanta Jean Martin in and by our certain promissory note in writing, of even date with these Presents, are well and truly indebted to American Homes, Inc. in the full and just sum of Four Thousand Three Hundred Ninety Four and 40/100, to be paid in sixty (60) equal and consecutive monthly payments of \$73.24 each, the first thereof to be due and payable on September 1, 1959.

, with interest thereon from maturity at the rate of 6 per centum per annum, to be computed and paid annually until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said American Homes, Inc.,

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, being the portion of a 7.31 acre tract measuring 219 feet by 110 feet at the southeastern corner of said tract, and according to plat of John C. Smith, Surveyor, dated April 22, 1959, being more fully described as follows:

BEGINNING at the southeastern corner of the 7.31 acre tract, running thence along line of lands of Albert Turner S. 70-30 W. 219 feet; thence N. 19-05 W. 110 feet; thence N. 70-30 E. 219 feet to point in a road; thence with the road S. 7-55 E. 110 feet to the beginning corner.

This mortgage is substituted for that certain mortgage executed by the mortgagors herein on or about July 11, 1959 and recorded in the R. M. C. office for Greenville County in mortgage volume 795 at page 351.
