

Herbst, which instrument was recorded in various Counties in the States of North Carolina and South Carolina; and

WHEREAS, an instrument dated as of December 12, 1957, was executed by the Company appointing J. A. Austin as Individual Trustee in succession to said Richard H. West (resigned) under said Mortgage and by J. A. Austin accepting the appointment as Individual Trustee under said Mortgage in succession to the said Richard H. West, which instrument was recorded in various Counties in the States of North Carolina and South Carolina; and

WHEREAS, such instruments were indexed and cross-indexed in the real and chattel mortgage records in various Counties in the States of North Carolina and South Carolina; and

WHEREAS, by the Mortgage, the Company covenanted that it would execute and deliver such supplemental indenture or indentures and such further instruments and do such further acts as might be necessary or proper to carry out more effectually the purposes of the Mortgage and to make subject to the lien of the Mortgage any property thereafter acquired, intended to be subject to the lien thereof and the Company executed and delivered to the Trustees a First Supplemental Indenture, dated as of January 1, 1949 (hereinafter called the First Supplemental Indenture), a Second Supplemental Indenture, dated as of December 1, 1949 (hereinafter called the Second Supplemental Indenture), a Third Supplemental Indenture, dated as of February 1, 1951 (hereinafter called the Third Supplemental Indenture), and a Fourth Supplemental Indenture, dated as of October 1, 1952 (hereinafter called the Fourth Supplemental Indenture), which First, Second, Third and Fourth Supplemental Indentures were recorded in various Counties in the States of North Carolina and South Carolina; and

WHEREAS, said First, Second, Third and Fourth Supplemental Indentures were indexed and cross-indexed in the real and chattel mortgage records in various Counties in the States of North Carolina and South Carolina; and

WHEREAS, the Company executed and delivered to the Trustees a Fifth Supplemental Indenture, dated as of March 1, 1958 (hereinafter called the Fifth Supplemental Indenture), which Fifth Supplemental Indenture was recorded in Counties in the States of North Carolina and South Carolina, as follows:
