sum of NINE THOUSAND and no/100--- (\$ 9,000.00) Dollars,

with interest at the rate of six (6 %) per centum per annum, to be repaid in installments of

Ninety and no/100--- (\$ 90.00) Dollars upon the first

day of each and every calendar month hereafter until the full principal sum, with interest, has been paid.
