Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the North side of Club Circle, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 21A and the adjoining one-half of Lot 20 on plat of property of Roy W. Boggess and Walter L. Miller, Jr., made by Jones & Sutherland, Engineers, January 8, 1960, recorded in the RMC Office for Greenville County, S. C. in Plat Book UU, page 7, said lot fronting 127.5 feet on the North side of Club Circle, running back to a depth of 338.9 feet on the East side, to a depth of 331.3 feet on the West side, and being 180 feet across the rear.
