# Tract 2, 147 South Church Street;

"All that lot or parcel of land situate, lying and being in the City and County of Spartanburg, State of South Carolina, lying on the East side of South Church Street; and having a frontage on said street of twenty-five (25) feet, and running back in parallel lines one hundred one (101) feet; being bounded on the north by property formerly owned by T. C. White and W. C. Rhodes (now owned by T. B. Pierce); on the east by property now or formerly of Hallett, on the south by an alleyway, and on the west by South Church Street."
