All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Garolina; County of Greenville, on the northern side of East Faris Road in the City of Greenville, being known and designated as Lot 35 on plat of Lanneau Drive Highlands, recorded in Plat Book Dat page 305, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of E. Faris Road at the point front corner of Lots 34 and 35, which point is 50 feet west of the Northwestern corner of the intersection of East Faris Road and Ottaway Drive and running thence with the line of Lot 34, N. 26-13 W.140 feet to a 10 feet alley; thence with said alley, S.63-47 W. 50 feet to an iron pin at rear corner of Lot 36; thence with the line of Lot 36, S. 26-13 E.140 feet to pin on East Faris Road; thence with the Northern side of East Faris Road, N. 63-47 E. 50 feet to the point of beginning.
