"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, All that lot of land in Oakland Township, Greenville County, State of South Carolina containing 3.97 acres more or less and being lots # 6,7,8,9, of Campbell Estate Near Pelzer, South Carolina. Beginning at an iron pin (old corner) running thence N 66.05 W 507 feet along the line of Bennett property to a corner on the edge of a branch; thence with the branch and line of Corrie Wright S 7-29 W 222.5 feet to a corner; thence with the branch and line of W. L. Wilson S 5-37 E 112.3 feet to a corner; thence, S 9-47 E along the branch and with line of W. L. Wilson 141 feet to a corner; thence N 83-39 E with line of Wilson 345 feet to a corner in Nelson line; thence N 24-00 E. with the line of Nelson 280.6 feet to an iron pin (old corner) and the place of beginning.
