TO ALL WHOM THESE PRESENTS MAY CONCERN: Evelyn P. Bulman

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Five Thousand and No/100 DOLLARS (\$ 5,000.00), with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid in monthly instalments of Forty-Nine and No/100 Dollars (\$ 49.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Eastern side of Mayfair Lane, in the City of Greenville, being shown and designated as Lot No. 31 on Plat of Holmes Acres, recorded in Plat Book Z, Page 1 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Mayfair Lane, at the joint front corner of Lots No. 31 and 30, and running thence along the line of Lot No. 30, N. 88-07 E. 203.1 feet to an iron pin; thence with the rear line of Lot No. 38, S. 5-01 W. 80.68 feet to an iron pin at the rear corner of Lot No. 32; thence with the line of Lot No. 32, N. 88-07 W. 193.4 feet to an iron pin on Mayfair Lane; thence with Mayfair Lane, N. 1-53 W. 80 feet to the point of beginning.

Said premises being the same conveyed to Boyce P. Bulman by Deed recorded in Deed Book 619, Page 170, and devised to the Mortgagor by Will filed in Apartment 766, File 17, in the Office of the Probate Court.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
