WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premides, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his accound by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3:00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 36 and a small portion of Lot 55 on plat of property of the Estate of Tully P. Babb, as revised July 1958 by Dalton and Neves, Engineers, recorded in Plat Book QQ at Page 162-163 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at concrete monument on the Eastern side of Montrose Drive (formerly Babb Avenue) 227.9 feet North from Cleveland Street at the corner of Lot No. 35 and running thence with the Eastern side of said Avenue, N. 6-50 W. 260.7 feet to an iron pin at the corner of Lot No. 37; thence with the line of said lot, N. 84-17 E. 250 feet to an iron pin; thence S. 6-50 E. 280 feet more or less to an iron pin in line of Lot No. 54; thence with the line of Lot No. 54 and 55, S. 86-33 W. 250 feet to the beginning corner.
