"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the northwestern side of Reedy Street, near the City of Greenville, being shown as the front half of Lot 20 on plat of Junction Heights, recorded in Plat Book C at Page 106, and being more particularly described as follows:
