MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Robert A. Bailey

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto B. E. Huff

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of One Thousand and No/100 -

DOLLARS (\$1,000.00)

with interest thereon from date at the rate of 6 per centum per annum, said principal and interest to be repaid: Nine months from date or when the within described property is conveyed by the mortgagor whichever event first occurs.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwestern side of Lion's Club Road shown as Lot No. 2 on a plat entitled Property of H. O. Huff recorded in the R. M. C. Office for Greenville County in Plat Book TT at Page 170 and being further described as follows:

BEGINNING at an iron pin on the Southwestern side of Lion's Club Road at the joint front corner of Lot Nos. 1 and 2 and running thence along the joint line of said lots, S. 60-55 W. 177.6 feet to an iron pin in the line of property now or formerly owned by Davis; thence along the Davis property S. 28-00 E. 100 feet to an iron pin at the corner of Lot No. 3; thence along the line of Lot No. 3, N. 60-55 E. 179.7 feet to an iron pin on the Southwestern side of Lion's Club Road; thence along Lion's Club Road, N. 29-05 W. 100 feet to the point of beginning.

Being the same property conveyed to the Mortgagee by deed of B. F. Huff to be recorded herewith.

It is understood and agreed between the Mortgagor and Mortgagee that the within mortgage is junior and second in lien to a mortgage from Robert A. Bailey to Fidelity Federal Savings & Loan Association dated January 14, 1963 for \$13,500.00 to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
