Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following described real estate situated in the County of Greenville, State of South Carolina:

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the Western side of Long Hill Street, in the City of Greenville, being known as the Northern portions of Lots Nos. Forty Rine (49) and Fifty (50), as are shown on a plat of AUGUSTA ROAD RANGHES, as recorded in the RMC Office of Greenville County, South Carolina, in Plat Book "M", at Page 47; and being more particularly described on a plat PROPERTY OF WILLIAM P. KELLER and JAMELLE M. KELLER made by R. K. Campbell, Engineer, dated January 17, 1963, and recorded in the RMC Office of Greenville County, South Carolina; in Plat Book "CCC", at Page 101, reference to said plat being craved for a complete and detailed description thereof.
