Now, Know All Man, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assignate, the following-described real estate situated in the County of Greenville, State of South Carolina: on the southern side of Pleasant Ridge Avenue and being known and designated as Lot No. 120, Section 1, of Pleasant Valley as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "P", at Page 93 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Pleasant Ridge Avenue at the joint front corner of Lots Nos. 119 and 120, and running thence along said Avenue N. 89-52 E. 60 feet to an iron pin; thence along the line of Lot No. 121 S. 0-08 E. 160 feet to an iron pin; thence S. 89-52 W. 60 feet to an iron pin; thence along the line of Lot No. 119 N. 0-08 W. 160 feet to the point of beginning.
