PARCEL I: Being all of lot 646 of the Tryon Development Company property known as Lake Lanier Subdivision as shown on a Plat of the same by George Kershaw, Civil Engineer, recorded in Plat Book H, Page 7, in the Office of Register of Mesne Conveyance, Greenville County, South Carolina, and described by metes and bounds as follows:

BEGINNING on an iron pin in the Eastern margin of East Lake Shore Drive, said iron pin being a corner common to lots 645 and 646 as shown on the aforesaid Plat, and running thence with the dividing line between said Lots 645 and 646 North 78 Degrees 18 Minutes East 130 feet to a stake in the Western line of Lot 652 as shown on said Plat; thence South A Degrees East 52.5 feet to a stake in the Western line of lot 651 as shown on said Plat, said stake being a corner common to Lots 646 and 647; thence with the dividing line between Lots 646 and 647 South 78 Degrees 18 Minutes West 130 feet to an iron pin in the Eastern margin of said East Lake Shore Drive; thence with the Eastern margin of said Drive North 11 Degrees 31 Minutes West 52.5 feet to the BEGINNING.

The above metes and bounds description was taken from a Plat entitled, "Property Belonging to J. R. Dunker, Lake Lanier Subdivision, Greenville County, South Carolina," dated August 11, 1954, made by H. B. Frankenfield, Jr., Ferest Engineer, and Surveyor, Tryon, North Carolina, which Plat bears No. 579, reference being had to said Plat in aid of the description.

The above described property is the identical property conveyed to Hazel D. Dunker by Nettie C. Frierson by Deed dated June 22, 1954, recorded in Book 504, Page 367, RMC Office for Greenville County.

PARCEL II: REGINNING at an iron pin in the Western margin of East Lake Shore Drive, which iron pin stands North 50 Degrees 06 Minutes West 46.8 feet from an iron pin in the Eastern margin of East Lake Shore Drive, which reference iron pin is the Northewestern corner of Lot 646 and the Southeastern corner of Lot 845 of the Tryon Development Company property known as Lake Lanier Subdivision, said beginning iron pin being also the Southeastern corner of that certain lot conveyed by Lanier Realty Company to Hazel D. Danker by Deed dated November 1, 1954, recorded in Book 720, Page 402, in the RMC Office for Greenville County and running thence from said beginning iron pin and with the Western margin of East Lake Show drive South 8 Degrees 45 Minutes East 20 feet to an iron pin; thence South 81 Degrees 44 Minutes West 103.5 feet to an iron pin at the waters of Lake Lanier; thence North 22 Degrees 11 Minutes East 23.2 feet to an iron pin, the Southwestern corner of the lot conveyed to Dunker by Lake Lanier Realty Company; thence North 81 Degrees 44 Minutes East 91.8 feet to the REGINNING.
