NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northern side of Dunbar Street, shown as Lot L on a plat of Greenville Trust Company, recorded in the R.M.C. Office for Greenville County in Plat Book C at Page 13, and being shown in the Greenville County Block Book Department as Lot 83-4-17, and having according to said plat and block book map the following metes and bounds, to wit:

"BEGINNING at an iron pin on the northern side of Dunbar Street and running thence with Dunbar Street S. 78-45 E. 50 feet to an iron pin, corner of Lot K; thence with line of said lot N. 16-15 E. 93 feet to a point on the boundary of Lot J; thence with line of said lot N. 78-45 W. 50 feet to an iron pin, corner of Lot E; thence with line of Lots E and F, S. 16-15 W. 93 feet to the point of beginning."
