"ALL that cortain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being known and designated as Lot No. 33 on plat of "Greenacre Dale", by C. C. Jones, C. E., dated June 1952, recorded in the R. M. C. Office for Greenville County in Plat Book "OO", at Pages 220 & 221, and having, according to said plat, the following metes and bounds, to-wit:
