F. S. Jones & Bertha Jones (hereinafter referred to as Mortgagor) **SEND(S) GREETING:**

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Six Thousand and no/100-----
DOLLARS (\$ 6,000.00-----), with interest thereon from date at the rate of **Six (6%)-----**
per centum per annum, said principal and interest to be repaid in monthly instalments of -----

WHEREAS, the Mortgagor may hereafter become indebted to, the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, **City of Greenville,** at **the Southeastern corner of Elder Street and Rebecca Street, being shown and designated as lot No. 14 on plat of Nicholtown Heights, recorded in Plat Book G at Page 18, and having according to said plat, the following metes and bounds, to-wit:**

BEGINNING at an iron pin at the Southeastern corner of Elder Street and Rebecca Street and running thence with the Southern side of Elder Street N. 89-15 E. 110 feet to a pin; thence S. 0-45 E. 40 feet to a pin at rear corner of Lot No. 15; thence with the line of lot No. 15 S. 89-15 W. 110 feet to a pin on Rebecca Street; thence with the Eastern side of Rebecca Street N. 0-45 W. 40 feet to the point of beginning.
