sum of TWELVE HUNDRED and no/100--- (\$ 1,200.00 ) Dollars,

with interest at the rate of seven ( 7 % ) per centum per annum, to be repaid in installments of

Fifteen and no/100--- (\$ 15.00 ) Dollars upon the first

day of each and every calendar month hereafter until the full principal sum, with interest, has been paid.
