Fifty and no/100------Dollars (\$150.00--) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwestern side of Sunset Drive in the City of Greenville, being shown and designated as lots Nos. 88 and 89 on Plat of Sunset Hills, recorded in Plat Book P at Page 19 and when described together has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Sunset Drive, at the joint front corner of lot Nos. 89 and 90 and running thence with the line of Lot No. 90, N. 47-30 W. 239.8 feet to pin on a 5 foot strip reserved for utilities; thence with the 5 foot strip, S. 66-W. 215 feet to iron pin at rear of lot No. 87; thence with the line of lot No. 87, S. 55-36 E. 325.5 feet to pin on Sunset Drive; thence with the Northwestern aide of Sunset Drive, N. 39-11 E. 75 feet to pin; thence continuing N. 48-09 E. 75 feet to point of beginning.
